## **The Land Conservancy Announces \$100,000 matching gift to save the Floating Fen in Chautauqua County**

The Western New York Land Conservancy is thrilled to announce a \$100,000 matching gift to save the Floating Fen, an incredible 223-acre property adjacent to the College Lodge Forest in Chautauqua County, one of the newest Land Conservancy preserves. Every dollar donated to the Floating Fen will be matched, dollar for dollar. The Land Conservancy community has until December 31, 2023 to raise at least \$925,000 to save the Floating Fen. Nearly \$300,000 has already been raised so far. When the community matches the challenge grant, they will be more than halfway to their goal at \$500,000.

This incredibly diverse forest is home to a unique wetland that includes a bog-like area the Land Conservancy calls “the floating fen.” Every summer, the floating fen comes alive with a carpet of blue flag iris, carnivorous sundews, and a trove of rare plants. The surrounding forest also teems with porcupines, beavers, fishers, great flocks of migratory songbirds, and other spectacular wildlife.

Once the land is protected, the Floating Fen will join the College Lodge Forest as a nature preserve, combining to form nearly 400-acres of protected land. The Land Conservancy will then maintain the forest and wetland, and it will open a walking trail so visitors can enjoy the site’s nature.

The combined block of forest will also become another important part of the Land Conservancy’s Western New York Wildway, the ambitious plan to protect, connect, and restore our region’s largest forests—from Northern Pennsylvania to the Adirondack Mountains and beyond.
