The Riverline to Conduct Impact Study, Seeks Community Input

The Riverline, a proposed 1.5-mile nature trail and greenway near downtown Buffalo, is entering the next phase of its development: a study to evaluate the social, economic, and environmental impacts the project will have on the community.

The Riverline Study is a required step before any construction can begin. This month, The Riverline will hold three public meetings to make sure the community knows the process and timeline of the study, meets the local team, and continues to have a say in helping to shape this great public space.

The Riverline, a project of the Western New York Land Conservancy, has engaged more than a thousand people who have helped to create a shared vision for the project. Hundreds of innovative ideas were generated and tailored to the neighborhoods through which The Riverline runs.

Once completed, The Riverline will transform the elevated former DL&W rail corridor along the Buffalo River into a string of vibrant and engaging experiences in nature that everyone can enjoy—right in the city, only minutes from downtown: an inspiring gathering place that will connect people to water, nature, and one another.

WHY ARE THESE PUBLIC MEETINGS IMPORTANT?

Community input is an essential part of The Riverline Study. All three meetings are free and will cover the same information, so community members need only attend one.
